**KUALA LUMPUR, Mon.**  
**A** LLEGED thefts from Jenderam during the evacuation of 1,700 under the Emergency Regulations had a sequel at Kajang when Thillyampalam, a senior Indian hospital attendant with 24 years' service, was acquitted of stealing two bicycle tyres.  
The Magistrate, Inche Harun, said he felt that all the ambulance men were implicated. "I do not understand why the whole lot of them were not charged," he added. Evidence was given that several articles were found in an ambulance which had gone to Jenderam to remove the sick and aged. After hearing five prosecution witnesses, the magistrate said that unless the four stretcher-bearers, two hospital attendants, and two policemen were all charged, he was not prepared to convict one man.

**Thefts Denied**  
All the men connected with the ambulance denied stealing the articles. Thillyampalam who was



represented by Mr. Robert Chelliah was acquitted and discharged. The court was told that the ambulance made a number of trips from Jenderam to Kajang. Mr. Deval, A.S.P., and Police Lieut. Porthouse, said they saw Thillyampalam coming out of a shop in Jenderam carrying two bicycle tyres. Suspecting that he had stolen the tyres, they searched the ambulance and found two ducks and a basket full of household utensils.
